The RCA Bylaws Article II SEC. 7 states: "Any Member not in arrears shall be exempt for life (a Life Member) from the payment of dues under the following conditions: (a) a Club member in good standing for the previous three (3) years and upon payment of twenty-five (25) times the then current annual dues; or (b) a Club member in good standing for the previous three (3) years and who is Sixty-Five (65) years or more of age and upon the payment of fifteen (15) times the then current Regular or Retired member dues; or (c) a Club member for twenty (20) years and upon payment of fifteen (15) times the then current annual dues. Nothing herein shall alter any existing Life Member's status."
